Market Perspective: Markets Look to Rebound After July Sell-Off

The past month was a busy one for economic data, geopolitical events and the stock market. Economic data was positive, but geopolitical events rattled some markets, causing stocks to sell off in late July before stabilizing during the first week of August.

The U.S. economy expanded at a 4 percent annualized rate in the second quarter according to the government's initial estimate. Export growth contributed significantly to the improvement, as did rising inventories. Inventories add to GDP growth when they increase and subtract from growth when they fall. The rising figure will prove to be excellent news if it foreshadows an increase in economic activity in the third quarter. Some evidence that this is the case came recently as the purchasing managers' index showed the manufacturing sector continues to expand. Rail shipments are also near their highs for the year, a sign of robust activity.

Speaking of manufacturing, the government is now reporting gross output numbers quarterly, even though the data lags by several months. Gross output is a far more accurate measure of the economy because it takes into account all the intermediate stages of production. The way GDP is calculated, a lot of companies and workers are not included because they don't produce final goods. The company that makes the widgets that go into cars and washing machines, for example, isn't counted in GDP. The government records final sales and the value of the widgets is included in the final price of the product, but this doesn't show the full picture of economic activity.

Gross output measures the output of every level of the economy. Instead of a \$16 trillion economy, the United States becomes an economy of more than \$30 trillion. Consumption decreases from 70 percent of GDP to approximately 40 percent. The single largest sector of the economy is manufacturing, accounting for more than 20 percent of economic activity. By comparison, the roughly 5 percent in the retail sector is barely half of business services. This is why strong manufacturing PMIs are so important. In addition to being a leading indicator, manufacturing plays a bigger role in the economy than GDP lets on.

Gross output is a much more sensitive number because it captures business slowdowns and booms across the economy. When sales of cars slow down, it doesn't af-

fect only the car dealer and manufacturer, but hundreds of companies that supply, service, finance and market the cars from start to finish. In 2009, for example, GDP was basically flat for the year. Gross output measured an 8 percent decline in output and a 10 percent decline in the private economy, a much more accurate read on the business contraction that was underway. Unfortunately, it takes longer to compile the data for gross output, so it lags GDP data by one quarter, but it paints a much clearer picture of the actual structure of the economy.

It has also been positive to see strong earnings data over the past several weeks. Almost 90 percent of the S&P 500 Index has reported, according to FactSet. The firm reports that 73 percent of companies beat their earnings estimates and 64 percent beat sales estimates. One of the bright spots was healthcare, which saw 88 percent of companies beat estimates. Over the past month, the healthcare sector of the S&P 500 Index moved into position as the best-performing sector year to date. Very close behind was the technology sector, which saw 82 percent of companies beat earnings estimates.

Energy and utilities weakened over the past month and slipped behind the two sector leaders but did see some of the largest sales beats. Revenue strength is important for future earnings growth, so these two sectors might be able to recoup recent losses if energy prices and interest rates cooperate. As for aggregate earnings for the S&P 500 Index, FactSet reports that earnings growth in the second quarter is running at 8.4 percent thus far, far above estimates of 4.9 percent growth.

Even though both economic and earnings reports were strong, stocks sold off in late July. There wasn't a singular reason for the slide, though investors had a number of reasons to be nervous. Geopolitical risk was dominated by the situation in Ukraine, as major energy exporter Russia faced sanctions from the United States and the European Union. This was exacerbated by Russia retaliating with sanctions of its own. Russian stocks and the ruble have borne the cost of the confrontation to this point. Sanctions haven't yet reached a serious level, though, and there is already talk of de-escalation.

A better explanation for weakness in stocks might be the Federal Reserve announcement of an October end date for quantitative easing. When QE1 and QE2 ended, stock market corrections followed. Both the post-QE1 and post-QE2 declines were driven

in large part by the European sovereign debt crisis, while the end of QE2 also saw the debt ceiling debate in the United States and concerns about a growth slowdown in emerging markets. Also, both QE1 and QE2 ended abruptly. Given the taper, the strengthening economy, and the lack of debt crises in Europe or elsewhere, another correction doesn't appear likely, even though the largest one-day

drop in the market last month came on the day following the Fed's announcement.

Stocks lost ground over the past month ending August 10, but the short-term technical picture is turning positive as we head into mid-August. Robust earnings and economic growth provide a strong fundamental backdrop for the markets and the recent sell-off improves

the valuation picture. Investors should remain on course with their long-term objectives. The overall trend for the markets and the economy is positive, and the recent dip in interest rates is good news for the housing sector. We still expect that the long-term trend in interest rates has shifted from falling rates to rising rates, but it may take until the end of the taper for this trend to become apparent.

Portfolio Updates

The S&P 500 Index fell 1.68 percent over the past month, while the Dow Jones Industrial Average slid 2.14 percent. The Nasdaq lost 0.58 percent, while the Russell 2000 slipped 2.63 percent. The MSCI EAFE fell 3.80 percent, hurt by the weaker euro.

Since inception of the portfolios on April 10, the Nasdaq is up 7.81 percent; the S&P 500 Index is up 5.37 percent; the DJIA has climbed 2.37 percent; the Russell 2000 is up 0.33 percent; and the MSCI EAFE is down 2.59 percent.

We made one portfolio change this month. In the **NTF Conservative Income Portfolio** we sold **Invesco Diversified Dividend Fund (LCEIX)** and purchased **Vanguard Dividend Growth (VDIGX)**.

The **Vanguard Aggressive Growth Portfolio** fell 1.84 percent in the past month and is up 6.13 percent since inception. Strength in Health Care (VGHCX) and Information Technology (VGT) helped moderate losses. Healthcare and technology were the two best S&P 500 sectors this earnings season in terms of the number of companies beating estimates, and their shares were rewarded. These two indexes are now the best performing this year, having passed utilities and energy over the past month.

The **Vanguard Straight Growth Portfolio** slid 2.37 percent last month. Many value funds have large exposure to sectors such as consumer staples and industrials, both of which were sold by investors in July. Exposure to small caps also stung in the past month as the Russell 2000 struggled to rally, though it had turned around its performance by August 10, showing the potential for a rally over the coming weeks. The portfolio is up 3.36 percent this year.

The **Vanguard Balanced Growth Portfolio** declined 1.96 percent over the past month; it

is now up 3.28 percent this year. Vanguard Wellesley Income (VWINX) performed the best, down only 0.85 percent thanks to roughly 60 percent of its assets being in bonds. Also it is positive that Vanguard High Dividend Yield (VYM) didn't decline more than the other holdings, despite outperforming this year. With interest rates moving lower for now, dividends are becoming more attractive and VYM looks poised to maintain its leadership in the portfolio.

The **Vanguard Conservative Income Portfolio** lost 1.38 percent in the past month and is up 1.87 percent this year. Even bonds were mixed last month due to some selling in the high-yield sector. Short-Term Investment Grade (VFSTX) was the sole winner, up 0.07 percent on the month. Vanguard Equity Income (VEIPX) fell 2.66 percent, stung by its largest sector, financials, moving with the market.

The **NTF Aggressive Growth Portfolio** fell 1.77 percent over the past month. However, ClearBridge Aggressive Growth (LMPFX), PRIMECAP Odyssey Growth (POGRX), Vanguard Health Care (VGHCX) and Vanguard Financials (VFH) each outperformed the S&P 500 Index. Baron Energy and Resources (BENFX) lagged, slipping 5.23 percent. The fund has midcap and energy exposure, and both of these market segments lagged. This portfolio is up 6.11 percent this year.

The **NTF Straight Growth Portfolio** declined 2.38 percent last month and is now up 2.63 percent this year. Wasatch Long/Short (FMLSX) disappointed with a 2.14 percent loss on the month. Vanguard Selected Value (VASVX) underperformed similarly to other value funds, losing 2.69 percent. Vanguard Dividend Growth (VDIGX) was the best performer, down 1.81 percent.

The **NTF Balanced Growth Portfolio** slid 1.67 percent last month, lowering its return

to 2.19 percent. Falling interest rates were good news for DoubleLine Total Return Bond (DLTNX), which increased 0.49 percent. Invesco Diversified Dividend Investor (LCEIX) was hurt for similar reasons as VEIPX: large exposure to the financial sector and heavy exposure to other weaker sectors. American Beacon SiM High Yield (SHYPX) slipped 0.98 percent as high yield saw some selling in July.

The **NTF Conservative Income Portfolio** slid 1.06 percent in the past month. The model has now returned 1.97 percent this year. Vanguard Wellington (VWELX) benefited from its balanced approach of two-thirds stocks and one-third bonds. It dipped 1.20 percent in the past month but is up 3.56 percent this year, putting it ahead of the DJIA. Thompson Bond (THOPX) dipped 0.42 percent, better than high-yield bond funds, though worse than Treasuries, due to corporate bonds being pulled lower.

The **NTF Global Portfolio** fell 2.24 percent over the past month. Since inception, the model is up 0.89 percent, easily outperforming the MSCI EAFE. Vanguard European Stock (VGK) fell 4.24 percent and Wasatch World Innovators (WAGTX) slipped 4.12 percent. Both funds are now down since portfolio inception in April. The two global funds were surprisingly strong, with losses of less than 1 percent. Vanguard Global Minimum Volatility (VMVFX) performed very well, in part due to its low-volatility nature, but also due to being hedged against currency fluctuations in a month when the euro slumped.

The **NTF Absolute Return/Down Market Portfolio** dipped 1.61 percent in the past month; it is up 2.27 percent this year. Tocqueville Gold (TGLDX) slid 1.66 percent last month as gold came off its highs from early July. Vanguard Utilities (VPU) was a disappointment, sliding 4.22 percent as investors sold defensive sectors and lower interest rates failed to spur buying.

User Guide

RANK: Our proprietary ranking system uses both technical and fundamental analysis to identify those funds expected to outperform over the following 6 months, on a risk adjusted basis.

ADVICE: Based on technical and fundamental indicators, we issue buy, hold and sell recommendations based upon expected future performance. We often avoid recommending funds that are extraordinarily volatile or are exposed to significant market risk.

PERFORMANCE RETURNS: YTD, 1-month, 3-month and 1-year returns are calculated each month based on the trailing returns. For 3-year and 5-year periods, returns are annualized.

YIELD %: We use the 30-day SEC Yield to provide the expected income generated by each fund, as reported by the fund in its most recent filing.

BETA: The 3-year Beta is the measure of the volatility, or systematic risk of the fund as compared to the market. A Beta of 1.3 will typically be 30% more volatile than the market.

STANDARD DEVIATION (SD): Also used to measure volatility, is determined from the monthly returns of the fund over the previous 3 years. Those funds with higher standard deviations are more volatile as compared to those with a lower standard deviation.

EXPENSE RATIO: The expense ratio is the fee charged by the mutual fund. This charge is deducted from the return of the fund, impacting performance. Please note, funds may have different share classes with varying expenses associated with each class.

Fund Spotlight: Vanguard Global Minimum Volatility Fund (VMVFX)

Two of the larger investment trends in recent years are low-volatility funds and minimum-volatility mutual funds. These funds offer returns similar to those of broad index funds but with an additional focus on minimizing volatility. Vanguard had been slow to enter this space before opening the Global Minimum Volatility Fund (VMVFX) in late 2013. While the name of the fund makes it sound very attractive, does it make sense for your portfolio? To find out, we'll explore the concepts of low and minimum volatility.

Low-volatility funds are rather simplistic, as they generally select only the stocks with lowest volatility in the relevant index. The problem with this method is that it can result in a portfolio with high sector concentration. In contrast, minimum-volatility funds also consider the risks between the different stocks in the portfolio, leading to a potentially more diversified portfolio. Either of these strategies can be appropriate at different times.

The most important thing to remember about volatility is that it's a measurement of one type of risk. In basic terms, volatility tells us how much a fund moves relative to its benchmark. A low-volatility fund is expected to fluctuate less than a high-volatility fund, but it will still move in the direction of the market's overall trend. If stocks are headed higher, the low-volatility fund will move higher; if stocks are fall-

ing, it will decline as well. Such fluctuations are due to market risk and can be identified by the fund's beta.

Beta measures the market risk of a stock or fund. The market, often represented by the S&P 500 Index, has a beta of 1. A stock or fund with a beta of 1.2 is expected to be 20 percent more volatile than the benchmark, while a stock with a 0.8 beta is 20 percent less volatile than the benchmark. So, a stock with a 1.2 beta will move about 12 percent if the market moves 10 percent – in either direction. A stock with a beta of 0.8 is expected to move about 8 percent. Beta does not tell you whether the asset in question is expected to outperform or underperform. An example is one of the holdings of VMVFX, Altria Group (MO), formerly Philip Morris. This stock has been a long-term outperformer for decades, but it currently sports a beta of only 0.44.

There's also the correlation between stocks in a portfolio to consider. As mentioned, one of the issues with some low-volatility ETFs is that they overweight sectors that tend to have low volatility over the long term, such as utilities. Sectors don't stay dormant forever, though, and concentrating a portfolio in one sector to minimize volatility is not necessarily a viable long-term strategy. At some point, every sector will experience a surge in volatility for one reason or another. In order to deal with this, Vanguard Global Minimum Volatility also takes into account the correlation between stocks when constructing its portfolio.

Low volatility became a popular investment strategy because research has shown that stocks with volatility were unloved by investors, yet performed better than the market as a whole. Tobacco stocks are a good example. Aside from investors shunning tobacco companies for ethical reasons, their business has been steady and boring. Yet they've persistently outperformed the stock market for decades. There are many other boring companies that have been in the same business for decades and do not have expansion plans or aggressive strategies. From the other side, many investors look to strike it rich and are willing to take risks to do so. They look for "hot stocks" of companies that are selling original products, entering new markets or creating new technology. Buying low-volatility stocks was an alternative for those seeking to achieve superior returns with less risk by exploiting these aggressive investors' emotional approach.

However, VMVFX is designed not to achieve low volatility but, rather, minimum volatility. It doesn't necessarily aim to outperform the market. The manager's goal is to purchase stocks that track a benchmark, such as the S&P 500 Index, but are less volatile. In the case of VMVFX, the benchmark is the FTSE Global All Cap Index Hedged.

The first main risk of owning a fund such as this one is underperformance. VMVFX doesn't ignore returns, but its mandate is to achieve minimum volatility, not beat the benchmark. The fund is very likely to underperform its

benchmark over the long run because it's aiming for minimum volatility, not high returns. Investors who are looking for a fund that beats the market with lower risk may want to look elsewhere.

Another risk is due to the rising popularity of this investment strategy. Since this trend has been growing for several years, low-volatility stocks have been bid up and aren't as cheap as they once were. After creating so many low-volatility funds and selling them to investors, fund companies have increased the correlation between these stocks. Whereas the stocks used to trade individually, now that they are lumped together into funds and attracting large investor inflows, these stocks are more likely to trade together.

In light of the increased risk, the Vanguard offering rates highly because it takes care to check for correlation between its holdings. Also, the fund avoids sector and geographic concentration. Unlike many other funds, VMVFX has a high level of diversification. Its largest sector is responsible for less than 14 percent of assets. In comparison, many other low-volatility funds have well over 20 percent of their assets in utilities. Even though utilities are generally low-volatility stocks, they are usually highly correlated with other companies in the sector. So, owning a lot of them gives a portfolio greater sector-specific risk than one that is more diversified.

VMVFX is actively managed and turnover will be high. Although the expense ratio is reasonable compared with that of other actively managed funds, at 0.30 percent, the fund is not tax efficient. VMVFX also hedges currency exposure, which can be very beneficial when the dollar is strong but could cause underper-

formance during periods of dollar weakness. Investors who want to maximize the upside from this fund will want to consider the overall trend in our currency.

SECTOR AND COUNTRY EXPOSURE

Due to the expected large turnover, the sector weights in the fund may fluctuate substantially. As of June 30, consumer staples was the largest sector, at 13.6 percent of assets, followed by 13.3 percent in healthcare, 12.7 percent in consumer discretionary and 12 percent in industrials. The smallest sector allocation was basic materials with 1.9 percent of assets, followed by energy and real estate at 6.5 and 6.9 percent of assets, respectively.

These weightings diverged greatly from the benchmark, which is no surprise given the fund's mandate. Financial services were substantially underweighted at 9 percent of assets, far below the benchmark's 19.1 percent allocation. Technology was also underweight at 7.7 percent of assets versus 12.7 percent for the benchmark.

Although we said the fund avoids single sector concentration, it does still overweight the classically defensive sectors: consumer staples, healthcare and utilities. The fund also overweights real estate, a sector that has a lower correlation to the overall market, due to the independent dynamics of the real estate market.

VMVFX is also globally diversified, which, unlike sector exposure, should make it more stable over time. The U.S. accounts for 45 percent of assets, developed foreign markets about 46 percent and emerging markets approximately 9 percent.

RECOMMENDATION

Low-volatility funds have done well over time, but part of their strong performance is from investors becoming excited about the strategy, thereby pushing up the prices of low-volatility stocks. The strategy has attracted investors who are risk averse but also want decent performance. We believe VMVFX is a useful fund for investors looking for lower volatility, but they should be willing to pay for it with lower expected returns versus the benchmark over the long term. For investors who want all-stock portfolios that have somewhat lower risk, Vanguard Equity Income (VEIPX) or Vanguard Dividend Growth (VDIGX) are solid choices in the domestic space. Another option is to reduce volatility the old-fashioned way, by shifting out of stocks and into fixed income or by diversifying into uncorrelated assets.

For investors looking for a global fund, Vanguard Global Equity (VHGEX) is the main competition. Since it has currency hedging, VMVFX is attractive for investors who want to broaden their international allocation, adjusted for currency exposure. The fund is one of the better-performing holdings in the NTF Global Portfolio, in part due to the foreign currency hedging, which paid off last month when the euro weakened versus the dollar. VMVFX has underperformed VHGEX since inception, but it outperformed strongly in late January and late July, when global markets sold off. Since this year has been negative for many of the broad foreign indexes and the dollar has strengthened, VMVFX is beating VHGEX. With the Fed tapering and the European Central Bank considering more action, the U.S. dollar should remain strong in the near term.
